EACH FALCON SCHOLARSHIP IS A FUNCTION OF SCHOOL TUITION, ROOM AND BOARD (50%), SCHOOL SCHOLARSHIP(25%), AND FAMILY COST (25%). FALCON SCHOLARS MAY CHOOSE TO ATTEND ONE OF SIX PREP SCHOOLS OFFERED BY THE FALCON FOUNDATION.
