EACH FALCON SCHOLARSHIP IS A FUNCTION OF SCHOOL TUITION, ROOM AND BOARD (50%), SCHOOL SCHOLARSHIP (25%), AND FAMILY COST (25%). FALCON SCHOLARS MAY CHOOSE TO ATTEND ONE OF FIVE PREP SCHOOLS OFFERED BY THE FALCON FOUNDATION. EACH SCHOOL HAS A DIFFERENT TUITION, ROOM AND BOARD COST WHICH CAUSES THE SCHOLARSHIP AMOUNT PER FALCON SCHOLAR TO VARY FROM SCHOOL TO SCHOOL.
