EACH FALCON SCHOLARSHIP IS A FUNCTION OF SCHOOL TUITION, ROOM AND BOARD (50%), SCHOOL SCHOLARSHIP( 25%), AND FAMILY COST (25%). FALCON SCHOLARS MAY CHOOSE TO ATTEND ONE OF FIVE PREP SCHOOLS OFFERED BY THE FALCON FOUNDATION.
